INDEPENDENT AUDITOR'S REPORT

To the Members of IRIS CLOTHINGS PRIVATE LIMITED

Report on the Financial Statements

We have audited the accompanying financial statements of **IRIS CLOTHINGS PRIVATE LIMITED** ("the Company"), which comprise the Balance Sheet as at March 31, 2018, the Statement of Profit and Loss, the Cash Flow Statement for the year then ended, and a summary of the significant accounting policies and other explanatory information.

Management's Responsibility for the Financial Statements

The Company's Board of Directors is responsible for the matters stated in Section 134(5) of the Companies Act 2013 ("the Act") with respect to the preparation and presentation of these financial statements that give a true and fair view of the financial position, financial performance and cash flows of the Company in accordance with the accounting principles generally accepted in India, including the Accounting Standards specified under Section 133 of the Act read with Rule 7 of Companies (Accounts) Rules, 2014. - (i) In respect of its fixed assets: -
 - (a) The Company has maintained proper records showing full particulars, including quantitative details and situation of the fixed assets.
 - (b) As explained to us, fixed assets have been physically verified by the management during the year in accordance with the phased programme of verification adopted by the management which, in our opinion, provides for physical verification of all the fixed assets at reasonable intervals. According to the information and explanations given to us, no material discrepancies were noticed on such verification.
 - (c) In respect of Immovable Property, the title deed is held in the name of the company.
- (ii) In respect of its inventory: As explained to us, physical verification of inventory has been conducted at the year end by the management. The discrepancies noticed on physical verification between the physical stocks and the stocks recorded in the books were not material and the same have been properly dealt with in the books of account.
- (iii) In respect of loans, secured or unsecured, granted to the parties covered in register maintained under section 189 of the Companies Act 2013:
 - According to the information and explanations given to us, the Company has not granted any loan to any such company, firm or other parties covered in the register maintained under Section 189 of the Companies Act, 2013.
